#### Why am I receiving this letter?

##### Your child is being invited to take part in a research study.

Before you decide whether they can take part, it is important for you to understand why the research is being conducted and what it will involve. Please take time to read the following information carefully. If anything is unclear or if you would like more information, please contact us (see 'further information' section below). Thank you for taking the time to read this.

**If you chose to opt-out of the research study for your child last year**, then your decision to opt-out is still recorded on our system and your child will **not** be taking part in the survey this year. You do not have to return the form again. If you have previously chosen for your child to opt-out of the survey but would like them to take part in Autumn 2026, please contact us at [joao.santos@manchester.ac.uk](mailto:joao.santos@manchester.ac.uk)

Please make sure to read this information carefully to understand what the research study is and to decide if you would like your child to take part or opt-out.

#### About the research

##### Who will conduct the research?

Professor Neil Humphrey, Manchester Institute of Education, The University of Manchester, is leading the study. The project is a collaboration between The University of Manchester, Anna Freud, Child Outcomes Research Consortium, Gregson Family Foundation, and Hampshire, Isle of Wight, Portsmouth and Southampton Local Authorities. Only a small group of researchers from University of Manchester and Anna Freud will have access to the project dataset outlined below; the remaining organisations support the project in other ways (for example, the Child Outcomes Research Consortium provide guidance to schools on their wellbeing provision).

##### What is the purpose of the research?

The aim of our study, the #BeeWell programme, is to look into the wellbeing (e.g. happiness) of young people across Hampshire, Isle of Wight, Portsmouth and Southampton. We also want to know what influences their wellbeing (e.g. relationships, physical activity).

##### Who is being asked to take part?

Your child's school has signed up to the #BeeWell programme, in which pupil's complete online surveys once a year, as follows:

##### Will the research be published?

We will publish our findings in journals, blogs, conference presentations, doctoral student theses, and summary reports on websites and social media. Participating schools and Local Authorities will receive summary feedback reports/dashboards. These publications only use aggregated data (e.g. summary tables and figures that always represent at least 10 survey responses). Your child will not be identifiable in any of them.

A de-identified copy of the project dataset will also be made available in the UK Longitudinal Linkage Collaboration's (UK LLC) trusted research environment (a highly secure digital lockbox). "De-identified" means that all direct personal details (e.g., names, dates of birth) are completely removed before any researcher can see it. Approved researchers will be able to analyse these de-identified data alongside other information such as health, education, employment and/or place-based data (see '*How will the information gathered be used?*' Below). By linking these together, researchers can produce major new insights for the public good. Access to the data is very strictly controlled. Only UK-based researchers who have been approved by the Office for National Statistics, the UK LLC review panel and the #BeeWell study team will be permitted to access it to conduct research.

#### *Disclosure and Barring Service (DBS) Check*

Members of the research team have each had DBS checks at the Enhanced Disclosure level.

#### *Who has reviewed the research project?*

The project has been reviewed and approved by The University of Manchester Research Ethics Committee 1 (Ref: 2026-11133-48591).

#### *Who is funding the research?*

The project is funded by The University of Manchester, The National Lottery Community Fund, and the Gregson Family Foundation.

#### **What would my child's involvement be?**

Your child will be asked to complete a survey in Autumn 2026, which will take them 20-30 minutes. This will be done online at school.

There are no significant risks or disadvantages to taking part in the survey. However, we will let your child know about a range of sources of support that they can seek out if any of the questions make them feel sad, worried or upset (e.g. parent/carer, Childline, member of school staff). There is no guaranteed benefit in taking part, but completing wellbeing surveys can help some young people to reflect on their lives.

#### *Will I or my child be compensated (e.g. receive money or vouchers) for taking part?*

There is no compensation available for participating.

#### *What happens if I do not want my child to take part or if I change my mind?*

It is up to you to decide if you want your child to take part or not. If you give permission, your child will also be asked if they want to take part. You can both back out at any time, without giving a reason. If after your child has taken part, you decide that you want us to remove their survey answers, you can contact us to delete their record in full (including the copy that UK LLC hold, if your child's data has already been deposited). You can do so at any point up until the end of 2029. This does not affect your data protection rights.

If you decide that you do not want your child to take part, please complete the short 'opt out' form at the end of this sheet and return it to us using the FREEPOST address by the specified date. If you prefer, you can telephone or email us using the information provided on the opt-out form.

### **Data protection and confidentiality**

#### *What information will you collect about my child?*

For your child to participate in this survey we need to collect information that could identify them, called "personal identifiable information". We will need to collect:

- Forename, surname
- Ethnicity
- Unique pupil number
- Date of birth
- Residential postcode
- Free school meal eligibility
- Year group
- Sex
- Special educational needs
- English as an additional language

This information will be provided by your child's school or local authority.

We will also be collecting information about your child's wellbeing, and the factors that influence their wellbeing. This includes questions about:

- Additional demographic information: Gender identity and sexuality, migration status
- Domains of wellbeing, including: Life satisfaction, mental wellbeing, self-esteem, stress and coping, mental health difficulties, and emotion regulation.
- Drivers of wellbeing, including: Health and routines (e.g., sleep, sexual health (Y9+ only), physical activity), hobbies and entertainment (e.g., creative hobbies, gaming), school (e.g., relationships with staff, school belonging), environment and society (e.g., neighbourhood safety), relationships (hips, bullying), e.g., friends and wellbeing support (e.g., information and advice outside of school).

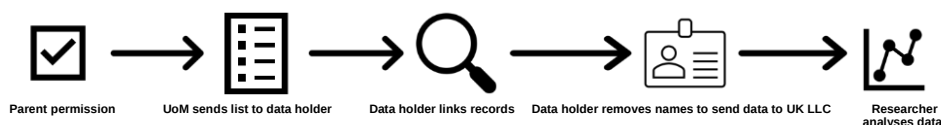
#### *How will the information gathered be used?*

We will link the information provided by your child's school or Local Authority to their survey answers. Other planned linkage, including via UK LLC, includes:

- Place-based data (e.g. air and noise pollution);
- Educational data (e.g. academic attainment in the National Pupil Database);
- Employment and earnings data (e.g. annual income in the Longitudinal Educational Outcomes database);
- Health data (e.g. referral/access to NHS-funded community and mental health services in the Community Services and Mental Health Services Datasets).

#### *How will data be linked and why is this beneficial?*

The basic process for data linkage is outlined below:



Linking our project data in this way significantly improves what researchers can learn about young people's wellbeing and how it influences (and is influenced by) what is happening in other aspects of their lives.

*Under what legal basis are you collecting this information?*

We are collecting and storing personal identifiable information in accordance with UK data protection law. This states that we must have a legal basis (specific reason) for collecting your data. For this study, the specific reason is that it is "a public interest task" and "a process necessary for research purposes".

*What are my rights in relation to the information you will collect about my child?*

You have rights under data protection law with reference to your personal information. For example, you can request a copy of the information we hold about your child. *Will my child's participation in the survey be confidential? Will their personal identifiable information be protected?*

In accordance with data protection law, The University of Manchester is the Data Controller for this project. This means that we are responsible for making sure your personal information is kept secure, confidential and used only in the way you have been told it will be used. All researchers are trained, and your data will be looked after in the following ways:

- All information will be treated strictly confidentially. Only our data managers access directly identifiable data (e.g. name, date of birth) \* except in instances where it is being securely provided to the organisations that hold the above-named datasets to enable data linkage. The rest of the #BeeWell research team access a pseudonymized dataset in which it is not possible to directly identify your child.
- All survey data will be stored on a secure, encrypted and password-protected server which only named members of the #BeeWell research team can access.
- All data will be processed in accordance with the General Data Protection Regulation (GDPR) law.
- If you agree for your child to take part in this study and with your permission, the non-identifiable survey data provided by your child will be accessible to approved researchers in UK LLC's Trusted Research Environment. This is to support additional research carried out for the public good, in accordance with The University of Manchester's Research Privacy Notice (see above link). As already noted, it will not be possible for researchers accessing the data to identify your child.

\* Please also note that individuals from The University of Manchester or other authorities may need to look at the data collected for this study to make sure the project is being carried out as planned. This may involve looking at identifiable data. All individuals involved in monitoring the study will have a strict duty of confidentiality to you/your child as a participant.
